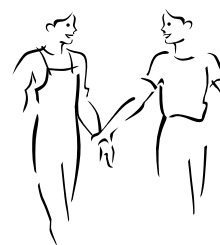

What We Have to Offer

- A minister(s) who will meet with the family and together plan a service celebrating the life of the deceased.
- Open style sanctuary with padded chairs which will seat approximately 200 people, extra chairs available
- Grand piano with accomplished pianist with a wide range of music available
- Infra-red headsets available , if required
- Family room to meet and assemble before processional
- Facilities for recording CD's of the service
- Arrangements to have a choir, if requested
- A Fellowship Hall and kitchen for a reception. **Catering to be arranged**
- "Reserved" signs for family parking
- A large parking area



Family Check list

- Contact the Church with name of the deceased and date of death.
- Provide the name and phone number of a family contact person.
- The Church office will contact the minister who will arrange a mutually agreeable date and time with the family contact person.
- Review the Church Guidelines and Fees (copy attached).
- If lunch/coffee is requested by the UCW, request contact information from the Church office. (Options & prices available on Page 6)
- Determine number of family members requiring “reserved seating”
- Arrange timing for floral deliveries – office hours or a time prior to service when Event Assistant is available
- Recommend the family to have ushers available
- Determine if the family wants bulletins produced and printed.
- Cheques for Honorariums and fees to be presented to the Event Assistant for distribution prior to the service.
- If visual presentation is to be used, our AV technician is mandatory

1. Catering for functions involving stewardship to the Community (e.g. funerals/memorial services)

The United Church Women (UCW) will organize the catering for these functions as required. The minister/administrative assistant will either advise the family contact of the UCW convenor's name and phone number, or will contact the UCW convenor with a name and phone number of the family. The UCW convenor, after discussion with the family, will coordinate all requests and costs involved.

Options available:

- a) Coffee, tea, juice
Set up and clean up
Cost: \$2/person based on estimated numbers (minimum 50 people)

- b) Dainties
Coffee, tea, juice
Set up and clean up
Cost: \$3/person based on estimated numbers

- c) Fruit Bread and cheese
Pickles, tea, coffee, juice
Glass plates & cups
Serviettes
Table set up and clean up
Cost: \$6/person based on estimated numbers

- d) Fancy sandwiches (*This option requires a minimum of 72 hours notice and a minimum of 50 people*)
Dainties, pickles, tea, coffee, juice
Glass plates & cups
Serviettes
Table set up and clean up
Cost: \$8/person based on estimated numbers

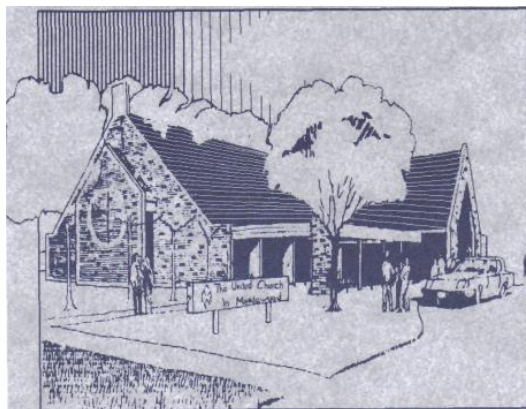
Should the family wish to have any other foods (eg. Veggie, fruit, or cheese trays), they should be brought to the Church kitchen prior to the service and they will be set out.

2. Catering for functions not involving community stewardship (e.g. weddings, baptisms, birthdays and anniversaries):

The United Church Women (UCW) shall be given first right of refusal to provide the catering service for these functions. The terms shall be determined in negotiation with the UCW but shall generally be similar to funeral/memorial service lunches.

Memorial Fund

AUTHORITY

Established by motion passed by the Council of the United Church in Meadowood on January 13, 1993.

OBJECTIVE

To create a fund to which contributions may be made by individuals or groups in memory of deceased members or non-members of the United Church in Meadowood to provide or to help provide for the future beautification and improvement of our Church.

MEMORIAL BOOK

A memorial book with the information entered will be displayed in the narthex of the Church. The information entered will include:

- a) Donor's Name (may be anonymous)
- b) "In Memory of..."
- c) Designated for. . . or undesignated

APPOINTMENT OF TRUSTEES

There will be five Trustees of the Fund, appointed by the Council for a three year term, with at least one representative from the Finance Committee, one from the United Church Women, one from the Property Committee, and two at large. A Chairperson and Treasurer will be selected from those so appointed.

SOURCE OF FUNDS

Without precluding others, these will include:

- a) Any person or group wishing to make a donation in memory of deceased relatives or friends.
- b) Contributions to the fund in lieu of flowers to funerals.

USE OF FUNDS

The sole use of funds received will be to provide for improvements and beautification of the Church which in the opinion of the Trustees will achieve the objectives of the fund. Donations will be accepted and administered by the Trustees under two categories:

- a) Designated Funds — this will allow donors the opportunity to specify the use of their contribution. The Trustees may direct the donors to an appropriate designation in consideration of the Church's "Wish List of Items".
- b) Non-Designated Funds — to be used as deemed appropriate by the Trustees of the Fund in consultation with the Church's "Wish List of Items".

The maintenance of any project should then become the responsibility of the appropriate Church committee.

OPERATION

All monies received by the Fund will be held in an interest-bearing account separate from any other accounts held by the Church. All monies received and expended by the Fund will be accounted for in the financial records of the Church by the Treasurer of the Fund in consultation with the Treasurer of the Church. Financial reporting will be included in the annual audited financial statements of the Church.

All other aspects of operation, such as publicity, etc. will be the responsibility of the Trustees, to be handled as they deem appropriate. For further information, please phone (204) 256-7002.

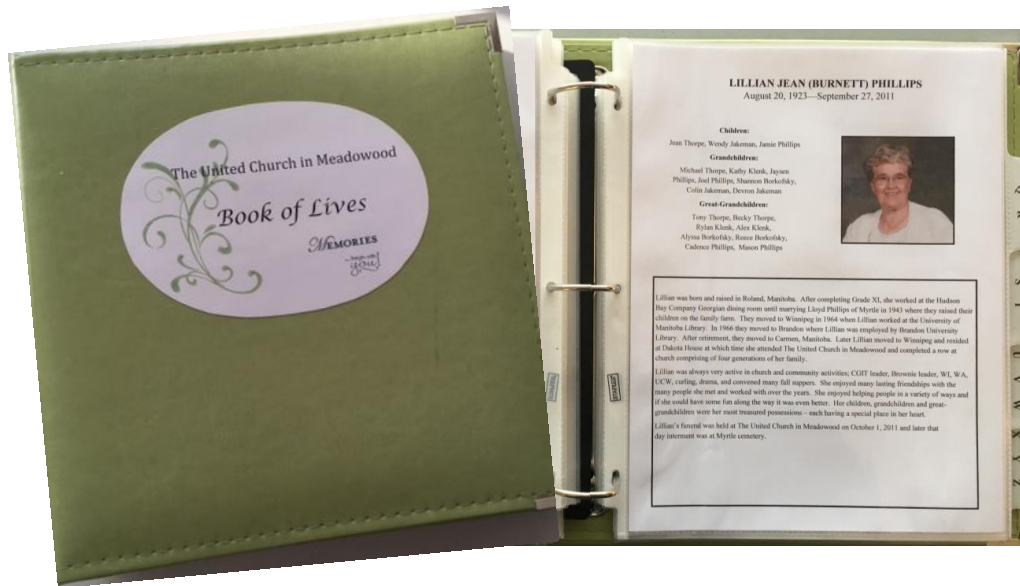

Lillian was born and raised in Roland, Manitoba. After completing Grade XI, she worked at the Hudson Bay Company Georgian dining room until marrying Lloyd Phillips of Myrtle in 1943 when they raised their children on the family farm. They moved to Winnipeg in 1964 when Lillian worked at the University of Manitoba Library. In 1966 they moved to Brandon where Lillian was employed by Brandon University Library. After retirement, they moved to Carleton Place, Manitoba. Later Lillian moved to Winnipeg and resided at Dakota House at which time she attended The United Church in Meadowood and completed a role at church comprising of four generations of her family.

Lillian was always very active in church and community activities; CGIT leader, Brownie leader, WI, W.A. I.C.W, curling, drama, and convened many fall suppers. She enjoyed many lasting friendships with the many people she met and worked with over the years. She enjoyed helping people in a variety of ways and if she could have some fun along the way it was even better. Her children, grandchildren and great-grandchildren were her most treasured possessions—each having a special place in her heart.

Lillian's funeral was held at The United Church in Meadowood on October 1, 2011 and later that day interment was at Myrtle cemetery.
